
Notes on Membership

Notes

- 1. This report is for 10/15/2010 instead of the end of the quarter 9/30/2010 since there were significant transactions in the first part of October and choosing this date does give a better picture of the branch's activities at this point in the year. The 9/30 bank statement did match the branch records exactly. A detailed list of the transactions is available on request.
- 2. We are carrying \$49 on the accounts as the Shape the Future membership earned in the spring of 2010. AAUW has announced a new membership program that indicates we will earn another 2 free memberships (expected \$49 value) through the 130th membership campaign. Implementation of this has not been clarified, and these free memberships may not be available before July 1, 2011 (for next year's budget), but it is suggested that all such credits be handled in the membership budget. [Mari Pino and Nancy intend to propose specific policies on how to allocate these discounts raffle prizes at events, hardship discounts, etc.]
- 3. The "photo contest" didn't work out as expected. Only Nancy and Doris submitted photos, so the drawing was done based on the people in the pictures (1 ticket for current members, 5 tickets for new members). The \$25 gift card was allocated: \$10 communications, \$10 marketing, \$5 membership (but that can be changed). The winner of the 9/25 drawing was Lib Laney.
- 4. The Wake County "project" (see Cash Flow Details) involved three members making donations to the branch to cover the cost of sponsoring the Wake League of Women Voters Women's Equality Day Celebration. The \$50 contribution (plus paypal fees) covered admission for two of the members, and the branch was listed as a sponsor in the program.
